

## TDA-Approved Mitigation and Treatment Measures for the Movement of EAB Regulated Articles from Quarantined Areas

Regulated Article	Mitigation and Treatment Measures
Firewood of all hardwood species	<ul style="list-style-type: none"> <li>• Remove bark and an additional ½ inch of wood<sup>1</sup> or</li> <li>• Kiln sterilization treatment (Table 1) or</li> <li>• Heat treatment at 140°F for 60 minutes or</li> <li>• Fumigation treatment (Table 2) or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>
Chips and Mulch of all hardwood species	<ul style="list-style-type: none"> <li>• Chip or mulch to less than one inch in at least two dimensions or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>
Nursery Stock of <i>Fraxinus</i> spp.	No treatment available. No compliance agreements. No certification. This article is not being moved at this time.
Green lumber of <i>Fraxinus</i> spp.	<ul style="list-style-type: none"> <li>• Remove bark and an additional ½ inch of wood<sup>1</sup> or</li> <li>• Kiln sterilization treatment (Table 1) or</li> <li>• Fumigation treatment (Table 2) or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>
Logs of <i>Fraxinus</i> spp.	<ul style="list-style-type: none"> <li>• Remove bark and an additional ½ inch of wood<sup>1</sup> or</li> <li>• Kiln sterilization treatment for logs &lt;3" dia.(Table 1) or</li> <li>• Heat treatment at 140°F for 60 minutes or</li> <li>• Fumigation treatment (Table 2) or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>
Other material including wood waste, living, dead, cut or falling including stumps, roots, branches of <i>Fraxinus</i> spp.	<ul style="list-style-type: none"> <li>• Chip or mulch to less than one inch in at least two dimensions or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>
Wood Packing Material <b>containing regulated green lumber, including but not limited to</b> , dunnage, crating, pallets, packing blocks, drums, cases, and skids.	<ul style="list-style-type: none"> <li>• ISPM accredited treatments or</li> <li>• Treatment/mitigations for green lumber of <i>Fraxinus</i> spp. as listed above or</li> <li>• Apply another TDA approved method<sup>2</sup>.</li> </ul>

<sup>1</sup> The bark and wood removed will be regulated separately. If intended for movement outside of the quarantined area, the removed bark and wood must be treated as described for chips and mulch.

Table 2. Fumigation Treatment using Methyl Bromide at NAP tarpaulin or chamber

<sup>1</sup> If the fumigation is conducted in a closed-door container, take the first reading at 1 hour instead of 0.5 hours.

<sup>2</sup> If the fumigation is conducted in a closed-door container, take the second reading at 2.5 hours instead of 2 hours.

<sup>3</sup> If the 4- and 16-hour readings would occur outside of normal working hours, then the fumigation may be extended to a total of 24 hours, instead of 16 hours. In that case, the 24-hr minimum concentration reading would be 25 (for the initial 3-lb dosage), or 42 (for the initial 5-lb dosage).
